Business of the Board

Financial and membership reports were reviewed and approved. While the Wyoming Medical Society remains in sound financial condition operating expenses continue to increase. WMS Board members unanimously voted to increase physician and physician assistant membership dues in order to allow WMS the ability to sustain the benefits to which members have grown accustom. WMS last voted to increase dues in 2004. Recent studies of surrounding states indicate that medical societies across the West are being faced with similar financial challenges and also, reluctantly, increasing membership dues. WMS is committed to serving our members to the very best of our ability and very much appreciate the medical community's support in our continued efforts to advocate on your behalf.

2011 Annual Meeting

Results from the 2010 physician survey were reviewed and carefully considered. WMS members indicated that they would be more likely to attend and participate in the annual conference if it were held Friday through Sunday, rather than Thursday through Saturday. In an effort to be as responsive to our members as possible, WMS has taken the necessary steps to change the contract with the Laramie Hilton Garden Inn to schedule our meeting Friday, June 10, through Sunday morning, June 12. We hope that this change, along with the input of the newly formed physician lead CME Advisory Committee, will bring new life to the conference and allow for increased availability and benefit to Wyoming physicians and physician assistants.

WYOPAC Update

Financial and membership reports were reviewed and discussed. WYOPAC is proud to have supported 33 candidates in the 2011 general election. State and Federal Legislative Issues
