Q3 Wyoming's tobacco tax rate of \$.60 per pack ranks 8th lowest in the nation. The national average is \$1.72 per pack. Q4 Physicians in Wyoming are required to attend continuing medical education (CME) to maintain their licensure in the State. Many physicians are now also taking part in maintenance of certification (MOC) programs to maintain board certification. MOC programs include more stringent continuing education requirements often at a higher cost, and generally involve high-stakes testing in order to maintain certifications. Wyoming physicians support continuing education requirements, but oppose mandates to maintain board certification. Do you support tying a physician's employment, reimbursement, or licensure to their participation in MOC activities?

No, physician board certification should not be allowed to be tied to state licensure, employment, hospital privileging, and/or reimbursement.

Please explain.:

Physicians went through the high stakes testing required in school and internship/residency. If a test is failed, it can be retaken for certification, but the license should not be at stake in that instance.

Q5 With 32 percent of Wyoming's population being covered by public payers (Medicare, Medicaid, CHIP, Federal programs, etc), and current projected budget shortfalls, how would you prioritize reimbursement to physicians? Please explain.

The reimbursement schedule should be be based on patient outcomes rather than survey scores. Survey scores are subjective, outcomes are objective. As an example: patient wants pain medication..gets script for PT and referal to an orthopedic surgeon, but the patient is unhappy and writes a scathing review, but goes to PT and meets with the surgeon...and the painful issue is resolved.

Q6 WMS supports physician-led healthcare teams with each licensed provider practicing at the top of their scope. Do you support licensed healthcare professionals expanding their scope of practice or increasing the specific tasks they can perform, such as psychologists prescribing or optometrists performing eye surgery, through rule making or legislation without proof of adequate expanded education, training and curriculum changes?

Yes, healthcare providers should be able to expand the scope of their practice through rule making and legislative changes.
