NONCOMPETE CLAUSE RESTRICTIONS

Noncompete Agreement Restrictions Take Effect July 1

BCBS LAWSUIT AND SETTLEMENT

Claim Submission Due July 29, 2025

The November 2024 Blue Cross Blue Shield (BCBS) lawsuit impacting physicians resulted in a \$2.8 billion antitrust settlement. The lawsuit, initiated in 2012, alleged that BCBS colluded to limit competition and lower reimbursement.

Physicians who provided healthcare services and submitted claims to BCBS between July 24, 2008, and October 4, 2024, are eligible to submit claims for a share of the settlement. Approximately \$160 million of the full settlement was specifically allocated for professional providers.

The settlement aims to address antitrust violations and promote fair competition within the healthcare industry. It is expected to bring changes to how BCBS operates, potentially leading to more competitive pricing and improved services for providers and patients.

The WWAMI Admissions Committee has an opening. Apply today.

The Wyoming Admissions Committee is comprised of four Wyoming physician members appointed to staggered three-year terms with an option to serve an additional three years.

Admissions committee members are responsible for interviewing those Wyoming applicants who have met certain academic criteria for admission to medical school. Interviews are conducted over the course of a week in January, February or early March. Members begin interviews Sunday afternoon and conclude the following Friday afternoon. 
